90-Night Comfort Guarantee

If you're not sleeping great, we'll exchange your mattress, hassle-free, for 90 days.

With our 90-Night Comfort Guarantee, you can buy with complete confidence. A new mattress can, and should, be a substantial investment in the quality of your sleep. Although every effort is made to find the correct mattress for you, at Mattress Mart, we understand that in rare circumstances it may be necessary to make an exchange to a more suitable comfort level. If you are not satisfied with your mattress within 90-Nights of your original delivery, we will be happy to assist you with a one-time reselection.

Program Details:

1. The 90-Night Comfort Guarantee applies to all purchases \$599 and up. Minimum purchase is based on the queen size price point for each model. The 90-Night Guarantee applies to set purchases and mattress alone purchases if placed on a solid platform surface or adjustable base.
2. Research has shown that it may take up to several weeks for your body to adjust to a new sleep surface. Therefore we ask that you sleep on your mattress for a minimum of 14 days. After that time if you determine you are still not satisfied with the comfort level, simply stop in to the store where you originally made your purchase and we will assist you in the reselection of a new mattress. Only **one** exchange is allowed.
3. The cost for the exchange is only \$99. If you choose a higher priced mattress, you would simply pay the difference *plus* the exchange fee. If you should select a lower priced mattress, Mattress Mart will refund up to \$300, minus the exchange fee.
4. All Tempur-PEDIC purchases will be allowed a FULL CREDIT to exchange to another mattress. If you choose a higher priced model, you would then simply pay the difference. There is **no** comfort exchange fee on Tempur-PEDIC models!!
5. If you were assessed an initial delivery fee due to your location, the delivery fee will be added to the exchange fee.
6. The value of any free pillows, free accessories, or gift cards given will be deducted from your reselection credit.
7. The 90-Night Comfort Guarantee does **NOT** apply to:
 - Non-standard and custom order sizes. Standard sizes are twin, twin xl, full, queen and king.
 - Adjustable bed bases.
 - Floor models and special purchase items.
 - Mattresses that have been replaced under a factory warranty or a previous comfort guarantee **do not** qualify for an additional comfort guarantee period.
8. You *must* notify Mattress Mart within 90 days to qualify for this guarantee.
9. All potential mattress comfort exchanges **MUST** meet the following criteria:
 - The original mattress set must be in *like new* condition with the Federal Law label attached.
 - **Any stains, rips, tears, odors, or damage to the mattress will preclude any comfort exchange.**
